The University of Burgos has experience in FP (PathogenCombat, SafeComms, Emap, Piedpiper), LLP (Koala, Migrapass) and IEE/Life (Hydrosolar, Resinbuil, Nimsec) programmes.

DAR research group aims at the development of technically cost-effective wastewater treatment processes for food industries (slaughterhouses, wine cellars, farming and aquaculture factory). Since 1994 its work is focused on the biological processes for the elimination of organic matter, nitrogen and sulphur from food industry wastewater.

Fixed film integrated bioreactor, patent n^oP200201891; with arranged media, patent n^oU200501010; have been developed.

Taking as an example, the research with MBR system deals with both the biological aspects and those one intrinsic to membrane technology, such as the optimization of flow density and the development of cleaning systems. In relation to the biological process, water treatment containing a high level of oil and grease in anaerobic conditions and, with regard to the cleaning methods, chemical in-situ cleaning is being studied

His research is centred in industrial wastewater treatment, mainly by biological processes. He has been the main researcher of 4 three-annual regional projects, the leader of other 27 projects funded by public services and companies. He has experience in the design of pilot and full scale industrial wastewater treatments plants conceived on the basis of research and development.

One full scale plant design led to the patent (ES P200703231, BOPI august, 10th 2010)

Novel strategies for safe and accurate catheter guidance and manipulation

Modern medicine is irreversibly shifting towards less invasive surgical procedures. Conventional open surgery approaches are systematically being replaced by interventions that reduce access trauma, thereby minimise pain, hospitalisation periods. In the perspective of patient safety, SCATH aims at minimizing these drawbacks specifically for a series of promising catheterization procedures with as common denominator treatment of cardiovascular disease, the main cause of death in the EU. The final product of SCATH will be a single software framework and robotic platform that integrates all the technological tools developed during the project.
